What is GDPR ?

GDPR explained

General Data Protection Regulation (GDPR) - data protection framework to give citizens back the control of their personal data.

User Dimension:

Right to be forgotten

Within the new Regulation, you now have the right to “be forgotten”. If you want your data to be deleted from any server or data storage, even if you have previously given consent, you can have it deleted.

Right to be informed

You have the right to be informed about how, why and where your data is used. It is the controller’s responsibility to inform you by request.

Right to portability

If you are unhappy with the way your data has been treated, it is possible for you to move your data to another controller.

Right of rectification and restriction

You can have your data corrected at all times if any information about you appears to be inaccurate or incomplete. It is the right of rectification. You can also request a limitation to the access and handling of your data, which is the right of restriction.

Right to object

You have the right to object, if you have been automatically profiled. You also have the right to object if it affects you significantly. Furthermore, you can object to direct marketing.

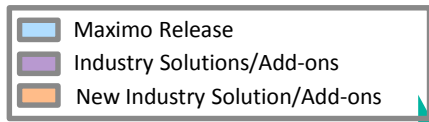

What is GDPR?

The General Data Protection Regulation seeks to create a more harmonized, unified data protection law framework across the European Union, with goals that include (1) reinforcing and enhancing data protection rights of EU data subjects (2) facilitating the free flow of data and (3) modernizing the law in line with emerging technologies.

4. Deleting personal information

Use the Maximo People Data Management Utility to delete personally identifiable information from specified attributes.

In the People application, you use the **Manage People Data** action to configure the removal of personal information, and you use the **Delete Person Data** action to delete that information.

Note: Deleted personal information cannot be recovered.

Note: The client is responsible for checking their results. We recommend verifying the data was removed as intended.

By default, you can manage attributes that are related to the following six objects:

- Phone
- SMS
- Labor
- Maxuser
- Person
- Email

6. Limitations

The Maximo People Data Management Utility does not remove personal information from the following object attributes:

- User ID
- Person ID
- Labor ID

To avoid divulging personal information, use pseudonyms for the above identifiers.

Similarly, the Maximo People Data Management Utility does not remove personal information from electronic signatures or audit records.
